Dear Mr. Letcher:

I am pleased to notify you that Winnefox Library System's second payment for operations in 2019 in the amount of \$236,223 has been electronically transmitted. This payment will allow you to continue to carry out this year's system plan as approved earlier by the Division for Libraries and Technology (DLT). Public library system funding is provided from the Universal Service Fund. A listing of this year's payments is enclosed, as well as a list of your system's mid-year duties and responsibilities.

Additionally, Winnefox Library System shall submit a plan to DLT specifically addressing how the Markesan Public Library, Neshkoro Public Library, and Oshkosh Public Library will correct the libraries' non-compliance with Wis. Stats. § 43.58 (6) because of the delayed submission of the 2018 Wisconsin Public Library Annual Report. The system board's plan shall address the libraries' specific actions to ensure the libraries submit future Public Library Annual Reports by the statutory deadline including addressing any hurdles to achieve compliance that are identified by the member libraries. The plan shall be submitted electronically to LibraryReport@dpi.wi.gov on or before the deadline for the Public Library System Plan and Certification of Intent to Comply for Calendar Year 2020.
