separate budget components. Those components are as follows: Winnefox Library System (funded mainly by state public library system aids); the Winnefox Automated Library Services (WALS) program that is funded by the participating libraries and Winnefox; and the Winnefox Cooperative Technical Services (WCTS) program, funded by the County Agreements in Marquette, Waushara and Green Lake Counties.
